## Change #1, 66024, 460

On page 3, replace Power Requirements, Fuse and Operating Temperature Range, and add:

- Power Requirements ..... 100 V ac to 240 V ac +10 %, -15 %, 50 Hz to 60 Hz, 40 VA max
- Fuse ..... 1A / 250 V, slow blow, 5 mm x 20 mm
- Operating Humidity ..... 80 % RH max (non-condensing)
- Operating Altitude ..... 2000 m maximum
- Operating Temperature Range ..... 15 °C to 35 °C, indoor use only

On page 4, remove CE Conformance and add:

- Safety ..... IEC/EN 61010-1, Installation Category II, Pollution Degree 2
